### Direct Cremation Service: \$895.00

This price includes the following services and merchandise:

1. Transfer of the decedent from the place of death (hospital or county mortuary\*) within New York's five boroughs or lower Westchester county to our funeral establishment;
2. Basic services of the funeral director and staff including: 24-hour availability, the arrangement conference, securing the original death certificate, obtaining cremation clearance from the Medical Examiner, filing the original death certificate with the New York City Department of Health (or other local registrar) and obtaining certified copies of the death certificate on your behalf, preparing and filing all necessary documents with other interested parties, safe and sanitary sheltering of the remains until the transfer to the crematory, and a basic share of facility overhead;
3. Cardboard alternative container (a casket is not required by law for a direct cremation service);
4. Transportation of the decedent to the crematory in our service vehicle (station wagon, van, or Suburban) within 10 miles of our funeral home;
5. Return of the cremated remains to our funeral establishment or to you (via mail).  
Note: Items 1 - 5 total \$895.00, as specified in our General Price List.

\* Deaths that occur at home or in certain adult residences, nursing homes, or other long-term care facilities may require additional staff for the transfer procedure. If this is the case — and we will advise you before you enter into a contract with us — add \$150.00 for extra assistance to our transfer fee.

Deaths that occur outside New York City in Nassau, Suffolk, and Northern Westchester counties, for example, will incur an additional transfer charge. These charges are based on mileage, and we will quote these extra fees before you engage our services. Please note that Suffolk County also has a \$100.00 mandatory medical examiner's (ME) fee.

### WHAT IS NOT INCLUDED IN THE ABOVE FEE OF \$895.00

Cash advances are third-party expenses that we incur on your behalf and are necessary for us to complete our service commitment to you. Funeral homes in New York *may NOT PROFIT on cash advance items* and their amounts do not differ between funeral homes.
